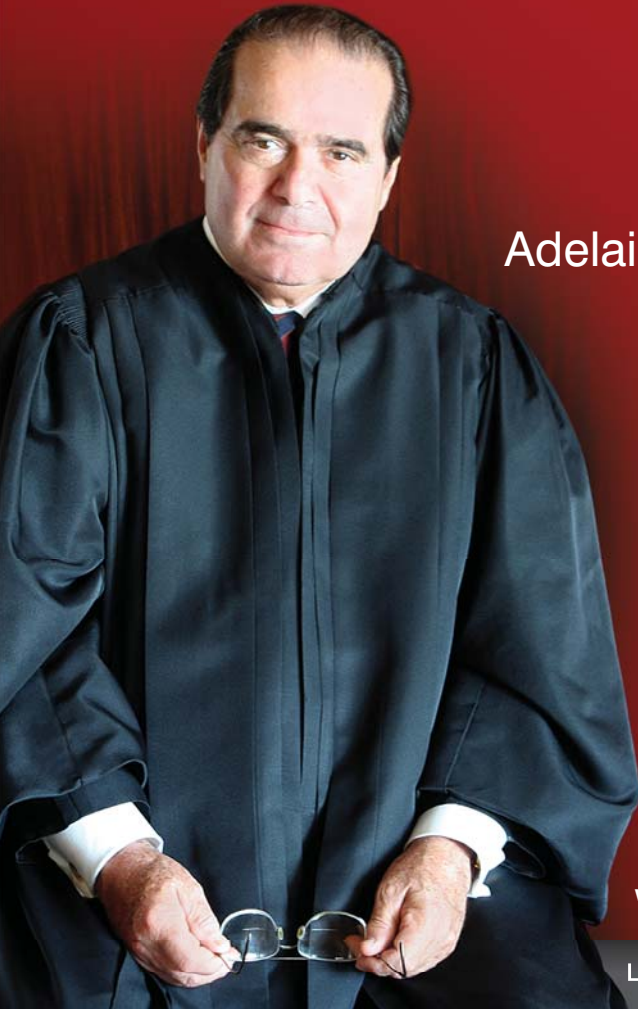

This 21st Century Advocacy Conference will be a major event on public advocacy in Australia

With a focus on modes of effective advocacy in various jurisdictions, the day will be divided into four core sessions.

Key note speakers for the three sessions on advocacy include:

- Justice Antonin Scalia of the United States Supreme Court
- The Honourable Michael Kirby AC CMG, Former Justice of the High Court of Australia
- Chief Justice John Doyle AC, South Australian Supreme Court

To mark the centenary of the *Female Practitioners Act 1911*, which abrogated all laws and rules of practice preventing women practising as lawyers, the fourth session will be a focused discussion on gender evolution and revolution. The discussion will consider the growth of and barriers to equal representation of women amongst the ranks of leading advocates.

During an informal lunch session, special guest The Honourable Alexander Downer will highlight some amusing aspects of the law.

An additional special feature of the program is the *InDaily* Young Lawyers' Breakfast. Special guests the Honourable Ronald A. Cass and Julian Burnside AO QC will chair a welcome breakfast designed especially for young practitioners.
